Introduction:

Following information is collected by us to to provide the services chosen by you.

Where your personal data is no longer required we will ensure it is either securely deleted or stored in a way which means it will no longer be used by the business.

Cookies

Automatic Logging of Session Data:

Each time you access the App/Website your session data gets logged.
